SUNDAY SCHEDULE FOR LIVESTOCK

The **4-H/FFA Livestock Areas** will be <u>closed to the public</u> on the **last Sunday (07/20)** of the 2025 Big Sky Country State Fair. Trucks, semis and trailers will be moving through the livestock areas throughout the day, so to ensure the **safety** and **wellbeing** of the general public, exhibitors, and animals, the areas will be closed off from the rest of the Fair.

For the mutual benefit of the Fairgrounds and 4-H/FFA exhibitors, Sunday will now become a processor load-out and barn clean-up day. 4-H/FFA market animals that are sold through the Market Livestock Sale are terminal projects intended for meat consumption. At the request of the meat processors, animals are to be transported to their final destinations beginning Sunday morning. All other 4-H/FFA animals will be released from Fair intermittently throughout Sunday at the discretion of each species.

Exhibitors are <u>still required</u> to be at the Fairgrounds for this day, as they are expected to care for their animals until release, help clean barns and assist species committees.

4-H/FFA families with reserved RV camping spots will be permitted to move onto the Fairgrounds beginning on Saturday, July 12th. All RVs must be in place by no later than Monday, July 14th at 6pm. RVs will be allowed to leave the grounds at any time starting Sunday, July 20th with attention to livestock transport trailers and load-out schedules.





PRIOR TO FAIR:

- 1. Entries are open to all Gallatin County 4-H and FFA members in good standing.
 - a. 4-H Members must be enrolled in their Project(s) by the enrollment deadline of March 1st, 2025 to be eligible to exhibit at the Fair.
- 2. Deadline for 4-H/FFA Fair entries is Friday, June 20th, 2025, 5:00 p.m. <u>ABSOLUTELY NO ENTRIES</u> <u>ACCEPTED AFTER THE DEADLINE!</u> NO EXCEPTIONS!!
- 3. Fair Entries are accepted online only. Information on how to register for Fair will be sent to all enrolled families in May of each year. **Refer to the appropriate species/project section for divisions/classes to enter.**

- <u>All 4-H members</u> must turn in their record book to the Extension Office by June 25th, 2025 at 5:00pm to be reviewed, scored and signed off on by project leaders or committees. Record books are to accompany each 4-H member to their interview(s). (See pg. 11-12 for Record Book & Interview information).
- 5. To exhibit at the Fair, <u>all 4-H exhibitors must interview</u> in each category they have a project in: Horse, Livestock/Small animal and/or Indoor projects. If an exhibitor does not interview, they will not be allowed to exhibit their projects at the fair. All exceptions must be preapproved by the 4-H office.

DURING FAIR:

MONTANA 4-H FAMILY CODE OF CONDUCT (updated 2025)

The 4-H Center & Montana State University Extension wants your participation in 4-H programs, events and activities to be filled with exciting experiences, new friendships and fun. To ensure a positive experience for all participants, it is expected that all 4-Hers and their families be considerate of others, participate fully in the programming and observe the following expectations. If a situation or question arises which is not clearly covered by this list, ask an Extension Faculty/Staff member, volunteer leader, or chaperone before acting.

While attending 4-H activities and events at the club, county, state and national level, I will:

- Obey all rules established by the 4-H program, the local 4-H program and all local, state and federal laws.
- Conduct myself at all times in order to be a credit to the club, school and community.
- Dress neatly and appropriately for the occasion and in accordance with the activity dress code.
- Show respect for the rights and property of others; be courteous at all times.
- Be honest and not take unfair advantage of others.
- Refrain from disruptive behavior and swearing.
- Demonstrate sportsmanship, modesty in winning and generosity in defeat.
- Attend meetings and sessions promptly and respect the opinion of others in discussion.
- Be respectful of the authority of adult volunteers, youth leaders, 4-H staff and others in leadership roles.
- Not use, accept or carry alcohol, drugs or tobacco, or associate with others using the substances.

FAMILY CODE OF CONDUCT (continued)

General Behavior Expectations for Families

- Work cooperatively with youth, families, volunteers, Montana State Extension Service faculty and staff and others in a courteous, respectful manner demonstrating behaviors appropriate for a positive role model for youth.
- Provide a safe, drug and alcohol-free environment; do not harm youth or adults in any way, whether through sexual harassment, physical force, verbal or mental abuse, neglect or other harmful experiences including divisive and slanderous statements through email and social media.
- Accept the results and outcomes of all 4-H contests and events with grace and empathy for all participants.

Consequences

- I understand, if I violate the General Behavior Expectations in the Code of Conduct, I will be asked to leave the event including 4-H meetings, fair and other 4-H activities/events. If dismissed from an event, it will be at my own expense. Repeat violations may result in loss of privilege to attend future 4-H activities, events or the ability to serve as a 4-H Volunteer.
- 6. All exhibitors must <u>observe all Fair Rules and Montana 4-H Family Code of Conduct</u>. The member/parent may receive a warning for a 1st infraction, and severe infractions will disqualify both the member and project from further participation in that year's fair. Entries not following rules may be disqualified or dropped one ribbon placing as decided by the Market Livestock Committee, Horse Committee, or Indoor Committee and/or 4-H agent and FFA Advisors. FFA Advisors will enforce rules for FFA members.
- 7. **Grievances** must be <u>filed in writing</u> to the Extension office within **24 hours of the incident**. A grievance committee of 4-H leaders and the county 4-H agent will review each grievance
- 8. 4-H/FFA members and volunteers are expected to dress appropriately while representing 4-H and FFA. Dress guidelines include no exposure of underwear and midriff area, no spaghetti strap or see-through shirts, and shirts must have an appropriate neckline. Closed-toe and closed-heeled shoes are required to be worn around animals. See showmanship division for description of appropriate show apparel.
- 9. All 4-H and FFA exhibits/animals must remain on display until time stated in Fair Schedule (see pg. 5-7) This includes taking exhibits/animals home at night. Exceptions may be made in the Horse Projects—please read the Horse Project section of this Fairbook for details. Removal of exhibits prior to end of Fair will result in forfeiture of all premiums earned & stall deposits unless otherwise arranged.

LIABILITY STATEMENT

Big Sky Country State Fair and Gallatin County 4-H Management reserves the right to interpret all rules and regulations and to arbitrarily settle and determine all matters, questions, and differences in regard thereto, arising out of and not covered by them. Any person who violates any of the rules as published in the Gallatin 4-H/FFA Fairbook will forfeit all privileges and premiums and may be subject to such penalty as ordered by Gallatin County 4-H management.

Submission of online entry as an Exhibitor of the Big Sky Country State Fair serves as agreement from exhibitor to comply with this statement:

In the event of General and Department Special Rules, the Department Special Rules will govern. Big Sky Country State Fair, Montana State Extension, Gallatin County Fairgrounds and Gallatin County, MT, their employees, agents, board members, or volunteers thereof will assume no liability for injury, damage, loss, death or theft, sustained by person, property or livestock of any exhibitor, exhibitor's family or employees, concessionaire or spectator. Every animal and article upon the grounds shall be under the control of Big Sky Country State Fair and Gallatin County 4-H management. Management will put forth every effort to ensure the safety of articles after their arrival, but in no case will it be responsible for loss, theft, damages, livestock injury or death which may occur while in transit or during the time of exhibition.

JUDGING, RIBBONS AND PREMIUMS

GENERAL JUDGING:

Exhibitor Age is determined based on the youths' age as of October 1, 2024;

- Cloverbud: 4-H Age 5 to 7 years old
- Junior: 4-H Age 8 to 13 years old
- Senior: 4-H/FFA Age 14 to 18.

The Danish System of Judging will be used (see below for more details).

- Youth may exhibit the current year's work only. Any article shown previously at Fair is not permitted.
- **NO** write-in entries will be allowed. All entries must be received upon Fair Registration deadline to be eligible to be exhibited at the fair.
- No person, other than exhibitors will be allowed in the show ring during the time of judging except the superintendent, judge, class supervisor, clerk, and ring steward. If any exhibitor or family member attempts to interfere with the judge in any manner during the judging time, or publicly expresses disapproval of the decisions made by the judge, the exhibitor may be excluded from further competition (refer to Code of Conduct)
- Judges have been carefully selected by the management and each is recognized for his/her capability in making expert decisions in the respective division for which chosen. All exhibitors entering the Fair will accept the judge's decision and agree to abide by their decisions. The decisions of the judges will be final in all cases.

THE DANISH SYSTEM OF JUDGING

Judging is based on comparison to a standard, not on comparison to others in the class.

Judges may consider skill level based on age and circumstance and may expect a higher performance from older 4-Hers so there is some variance within the standard.

Every entry should receive a ribbon; some projects may have exceptions for certain divisions (i.e. *Premiums are <u>not</u> paid for market classes or animal educational posters - see Department Rules for specifics).

AWARDS - FLATS:

Purple Ribbon: Excellent quality. Usually reserved for top two or three of the group, but not limited in number given. **Blue Ribbon**: Superior quality. The standards have been met. Denotes adequate work.

Red Ribbon: Average to above average quality. Shows signs of quality but does not completely meet the standards. Some areas need further improvement.

White Ribbon: Below average quality. Does not meet standards. Denotes improvement needed.

Participation Ribbons: (Cloverbuds) Are given when members exhibit for personal satisfaction, not to see how their exhibit compares to a standard. Cloverbud entries are non-competitive & receive only green participation ribbons.

AWARDS - ROSETTES:

Grand Champion & Reserve Champion are given at the judges' discretion when the judge feels there are projects that deserve the title of Grand Champion and Reserve Grand Champion. The pink and purple rosettes are saved for the overall winner of the division/class.

AWARDS - PREMIUMS:

Premiums are given on the below ribbon types/colors.

White \$2.00 Red \$3.00 Blue \$4.00 Purple Flat \$5.00 Pink Rosette \$6.00 Purple Rosette \$8.00 Blue Rosette \$10.00 (livestock educational posters only)



RECORD BOOK AND INTERVIEW EVALUATIONS

<u>REMINDER</u>: <u>All</u> Gallatin County 4-H Members must participate in a project interview evaluation with their record book to complete a project and enter exhibits in fair.

<u>All 4-H Members</u> participating in fair are required to turn in all Animal <u>and</u> Indoor project records and project workbooks to the Extension Office by June 25th, 2025, by 5:00 pm.

Record books are required to be up to date and include:

- My 4-H Year* (One per member)
- Project Records: Animal or Non- Animal Project Financial Journal* (one per project)
- Project Curriculum/Workbook for each project (w/ 7 completed activities each year for most projects)
- Optional: 4-H Story youth may include photographs and write a 4-H story for their record books

*Members and Project/Club leaders must sign the record book(s) and project curriculum/workbooks prior to your fair interviews.

Record Book & Interview Scoring Procedure - Composite Scores

With both record-keeping skills and interview skills being equally important to develop in our youth, the two areas will be scored and totaled to determine Project award nominees.

- **Record Books:** Upon turn-in of your Record Books, Project & Club leaders will sign, review and score your records based on completeness, content and project standards utilizing a record book rubric. **This will be your Record Book score.**
- Interviews: During the Project Interviews prior to Fair, a judge will evaluate members on their interview skills (eye contact, confidence, attire, ability to answer questions), their 4-H Year experience and project knowledge utilizing an interview rubric. This will be your Project Interview score.
- **Composite Score:** The Record Book score (max points = 82) and the Project Interview score (max points = 48) will be totaled together for a **Composite Score** (max points = 130).
 - Members with a Composite Score of **110 or above** (85% or 'B grade level') will get nominated to be considered for a Project Award. Those nominated will be asked to re-turn in their completed Record Books in September for final review. Project Awards are presented at the end-of-year Awards Banquet.

Procedure for Livestock/Small Animal and Horse Interviews:

Livestock/Small Animal and Horse Project Interviews will be on the Thursday and Friday prior to fair week (July 10th and July 11th, 2025 from 4pm-8pm each day). *NOTE: Dog & Cat project interviews will be included on these dates as well.

- 6. Indoor entries are not to be removed from the Gallatin Fairgrounds until the end of fair. If items are removed early, premiums may be forfeited.

GENERAL RULES FOR FOOD ENTIRES:

- 1. <u>ALL</u> food entries will be accepted on **Sunday**, July 13th for indoor exhibit judging and interviews.
- 2. All food items may come to the fair plated to the desire of the youth, although most attention will be paid to the quality of the goods. While sitting with the judge, a serving will be provided to the judge and a portion of the goods will be transferred to a disposable plate with a zip lock bag to be displayed for the remainder of the fair. Please bring necessary serving utensils (pie scoop, small spatula, fork etc).
- 3. All food entries, including hot and refrigerated, must be presented for judging at a food safe serving temperature. If judge deems temperatures are not safe, they will not sample.
- 4. Complete recipe for all food exhibits must be attached. For commercial mix, paste directions on card and eliminate reference to brand. <u>Do not</u> use packaged mixes unless specified in class number.
- 5. Exhibitor to bring a minimum of 3 servings of their food product (i.e., 3 cookies, 3 muffins, 3 biscuits, 3 servings of cake, etc.). If bringing a cake or pie or loaf of bread, bring entire food product (unsliced). After judging, the exhibitor may take home all but that mentioned above in Rule Number 2.
- Cakes should be exhibited out-of-pan. Cupcakes should be baked without liners. Bread should be baked in an 8"x 4" or 9"x 5" pan unless it is a braided or shaped bread; pies should be baked in a 9" or 10" pie pan.
- 7. Food entries will be judged on appearance (attractiveness, display, uniformity, cleanliness, etc.), adherence to entry rules (recipe attached, appropriate number of servings), texture and flavor.
- 8. Judging will be based on age division: Junior (Ages 8-13) and Senior (Ages 14+)

Division Rules:

- 1. Exhibitor must use flowers/vegetables grown in own garden.
- 2. Exhibits will be judged for uniformity, maturity, various characteristics, free from disease, insects, and injury.
- 3. All vegetables & fruit must be exhibited on a white 9" paper/foam plate and placed into a plastic bag.
- 4. Vases/containers are to be provided by exhibitor, use creativity as the type of container enhances your display, however containers will not be considered in judging. Foam cups or tin cans <u>will not</u> be allowed.

When entering Vegetables, follow the below harvesting guidelines:

• For all root vegetables: cut the tops off, leaving approximately ³/₄ inch of top intact with the root. Wash roots gently to avoid injury to the skin. If storage is necessary, put them in a cool, moist place. Root crops include beets, carrots, radishes, rutabagas, turnips, parsnips, artichokes, horseradish, etc.

- **Head Lettuce:** trim lower leaves from heads and do not leave roots intact. Choose large, heavy, or solid heads. Remove the roots and underground portion of stem but leave crown of Swiss Chard, Endive, Leaf Lettuce, Kohlrabi, Parsley, Dill, Spinach, etc.; wash if needed and keep in a moist & cool place.
- **Onions:** approximately 1 week prior to Fair, pull and twist tops; remove outer layer of (dirty) skin. Spread them in an open shed so air will pass over them until fair time. Remove the tops and clip off roots; avoid damaging the node or basal plate. Choose well-formed bulbs; avoid "doubles", thick necks, etc.
- **Green Onions/Leeks:** Dig immediately prior to going to fair; avoid damage to node or basal plate. Remove outer layer of skin to get soil off and wash. Choose specimens that are well blanched or white.
- **Corn:** Husk leaving 2-3 layers for protection against drying. Cut off stem back to the outer layer of husk. Choose well-pollinated and well- developed ears with good tip cover/fill, in the "milk stage".
- **Cucumbers:** Harvest by cutting stems; leave approximately 1/4 inch of stem; avoid injury to fruit. Wash if necessary; choose well-shaped specimens.
- **Kohlrabi:** Remove roots but leave the above ground portion of stem. Remove leaves; avoid injury to the skin. Tenderness is important.
- Peas: Choose ones that are sweet, moist, and tender; not bitter, dry, tough, or woody. Wash if necessary.
- **Potatoes:** Immediately after digging allow the skin to "set". Avoid rough handling or cuts, skinning, or bruising, wash gently. Select medium to large sizes that are smooth and free of defects.
- **Rhubarb:** Remove all green portion of leaf; leave base of petiole (stem) intact and wash; stalks must be tender and juicy.
- **Summer Squash:** Leave stem; choose tender specimens. For the long type, they may be 5-8 inches long. For the round type and crooked necks, choose those that are very tender and succulent. Some types are ready for use as soon as the blossom has withered.
- **Tomatoes (red):** Remove stems; wash and avoid injury. Choose those free of cracking. Green Tomatoes: Leave stems; choose specimens that aren't turning red.

PORTFOLIO REQUIREMENTS:

Portfolios may be black or white presentation binders in a horizontal orientation of 11" x 8.5" or 12" x 9". Images should be printed (maximum 8 x 10 or minimum 5 x 7) and mounted on black or white cardstock sized and inserted into the presentation book. An image may be used in the Process Portfolio or the Personal

Process Portfolio should consist of a minimum of 12 images and a maximum of 24 that reflect a progression of skill development, technical experimentation, and exploration composition. Up to 3 images may be displayed per spread, along with a brief description of the process on display.

Personal Project Portfolio should consist of a collection of 8-12 images that reflect the photographer's best work and are tied together by a theme. One image per spread. The photographer may include a brief statement at the beginning of the portfolio about the theme images. The portfolio will be judged on the collection of images as a whole. The photographer may also prepare and enter exceptional images from their Personal Project portfolio to be judged individually.

PHOTO BOARD REQUIREMENTS: (refer to image below)

Posters will be 22" X 28", to be displayed horizontally. Do not use foam board for the poster.


Mount photos neatly and securely to the backing. Double sided tape works very well and keeps the photos from curling. DO NOT use photo corners, scrapbooking tape, rubber cement, white glue, or glue stick. Use either black or white backing boards.

Photos on the poster may be 4" X 6" or preferably 5" X 7". Photos must all be the same size! They can be either portrait or landscape orientation, or a mixture of the two. Work to make the display aesthetically pleasing. Photos must be standard sized prints...NO HAND CROPPING!

4-H/FFA LIVESTOCK & SMALL ANIMAL PROJECTS RULES FOR 4-H/FFA ANIMAL PROJECTS

REQUIREMENTS:

Reference Fairbook General Rules (pgs. 8-12), Gallatin County 4-H/FFA Livestock Contract, and Species-specific contracts (if applicable).

LIVESTOCK CODE OF ETHICS:

Montana 4-H is based on principles of positive youth development. We believe that all producers and exhibitors of livestock have an interest in maintaining a reputation of integrity, as well as an interest in presenting a positive and progressive image at livestock shows. Because we believe that all livestock producers want to produce a wholesome, safe, and reliable source of food for the public, we have adopted the following "Livestock Code of Ethics". Violations of this code are considered unethical in the raising, showing, and exhibiting of livestock for shows and fairs.

- 1. **Sportsmanship:** All exhibitors and their families are required to conduct themselves in a positive, honest, sportsmanlike manner during shows. Losing gracefully is just as important as winning humbly. The following practices are prohibited:
 - a. Unsportsmanlike conduct, such as abusive language to show officials, other exhibitors, or the public.
 - b. Misrepresenting the age of an animal for the class in which it's shown.
 - c. Criticizing or interfering with the judge, other exhibitors or show officials while at the show or fair may result in an individual or group being expelled, placed on probation or declared ineligible to exhibit at the show.
- Treatment of Animals: All animals are to be treated in a humane manner with adequate feed, water, and shelter provided. Physically abusing an animal is unacceptable and will not be tolerated. Exhibitors or anyone associated with an exhibitor who abuses their animal(s), for whatever reason, will be disqualified from the show. Striking an animal to cause swelling or a mark is absolutely prohibited.
- 3. Administration of Drugs: of any kind or description, internally or externally, except for treating a recognized disease or injury is prohibited. For this code, "drug" shall mean any substance commonly used by the medical or veterinary professions that affect the circulatory, respiratory, or central nervous systems of an animal. Only those drugs approved and labeled for use on animals can be administered and proper dosages and withdrawal times must be observed. Exhibitors own and manage livestock and are ultimately responsible to see that they follow appropriate and approved practices.
- 4. In addition, the following practices are prohibited and unethical:
 - a. The use of any diuretic on any animal.
 - b. The use of alcoholic beverages in the feed or administrated as a drench.
 - c. Treating or massaging any part of the body, internally or externally, with an irritant, counter-irritant or other substance to temporarily straighten a weak back or loin or to produce unnatural animation.
 - d. Minimizing the effects of cramps by feeding or injecting drugs, depressants, or applying packs or using any artificial contrivance or therapeutic treatment exempting normal exercise.
 - e. Administration of human tranquilizers to calm down animals.
 - f. Surgery of any kind performed to change the natural contour or appearance of the animal's body, teeth, hide or hair. Not included is the removal of teats or horns, clipping or dressing of hair, trimming of hooves.
 - g. Insertion of any foreign material under the skin.
 - h. Any attempt to change the natural color of any animal, either purebred or crossbred, by changing the color of or adding false hair, fleece, or skin at any point, spot, or area of the animal's body.

VIOLATIONS of the rules and regulations may result in forfeiture of all premiums and awards, disqualification, change in sale order, expulsion or probation of the exhibitor or organized group(s) the exhibitor represents and the exhibit or livestock involved in the violation. Decisions of the Gallatin County 4-H/FFA Market Livestock Committee, Gallatin County Extension 4-H Agent and FFA Advisors will be final. Such action will require application for readmission under such terms as the Gallatin County 4-H/FFA Market Livestock Committee, Gallatin County Extension 4-H Agent and FFA Advisors

may prescribe before the group or individual is allowed to exhibit at future shows. The Gallatin County 4-H/FFA Market Livestock Committee, Gallatin County Extension 4-H Agent and FFA Advisors reserves the right to interpret rules and arbitrarily settle all differences and questions not adequately addressed by the above Code of Ethics.

OWNERSHIP:

- 1. Exhibitors must use ONLY their Project Animal(s). Project animals are defined as animals tagged, tattooed, weighed, or declared before the species deadlines.
- 2. All registered stockowners must show original breed certificates in own name or transfer papers including ownership. Livestock must be owned or available under contract as outlined in the table Proof of ownership, contract or share agreement will be required. Ownership rules do not apply to breeding stock that is an offspring of a female project animal owned by the exhibitor.

EAR TAGS: Barn Superintendents may identify all livestock, upon arrival at the Fairgrounds, with ear tags or tattoos. Market Beef, Sheep, Goats and Swine animals will be tagged at a date set by the respective committees **PRIOR TO FAIR**

CARE & DISPLAY OF ANIMALS:

- All animals, except dogs and cats, must have a completed health form and a general health inspection the day of delivery to the Fair. NO ANIMAL WILL BE ALLOWED TO UNLOAD AT THE FAIRGROUNDS WITHOUT THE INSPECTION! The general vet inspection may be obtained for free at each species-specific barn during check-in times (see schedule). All animals showing infectious ailments will be sent home. All poultry must be pullorum free. All female beef and dairy cattle over 1 year of age must have a brucellosis certificate with health inspection. See Horse Department section for veterinarian inspection and vaccination protocol.
- 2. **EXHIBITORS MUST FURNISH THEIR OWN FEED AND BEDDING -** The Fairgrounds provides the first bedding of wood shavings. Additional days will be provided by exhibitors.
- 3. ALL ANIMALS MUST BE FED, WATERED AND STALLS PICKED UP REGULARLY THROUGHOUT THE DAY, EVERY DAY. Exhibitors must clean stalls their animals occupied.

TYING ANIMALS: For security reasons, all beef and dairy animals (except cow/calf pairs and dairy goats that are in pens) **must** be tied with a neck strap, chain, or rope, in addition to halter rope. Pens will be available for cow/calf pairs upon request on your registration; they must be halter broke and be led from the truck to the pen.

DISPLAY OF OTHER AWARDS: Exhibitors may not display awards won at previous shows until after the class in which they are showing has been judged.

HERDSMANSHIP:

Livestock Exhibitors will be responsible for the appearance, condition and cleanliness of the stalls and barns assigned to them. Neglect of animals will constitute being sent home and disqualified. Every 4-H or FFA member exhibiting livestock is automatically entered in the herdsmanship contest. A \$25.00 award will be presented to an individual in each barn area who displays the best herdsmanship. Rob Brownell provides these awards in memory of his father Bob Brownell. Consideration for the Award:

- 1. Stalls and alley in front of your pen kept clean and orderly during the entire Fair.
- 2. Feed and proper care of your animals throughout the Fair.

- 3. Courteous and polite to fellow 4-H & FFA members, adults, and Fair visitors in the barn and elsewhere on the Fairgrounds.
- 4. Neat and clean dress.
- 5. Equipment neatly stored.

SHOW DAY ATTIRE:

Showmanship Classes: White collared dress shirt, long sleeve. Shirt needs to be tucked in. Tie is highly recommended. Black or dark blue jeans for 4-H members. Official FFA dress for FFA members. Polished boots for large livestock showmen. Clean tennis shoes are acceptable in sheep, rabbit, and poultry divisions.

Market and Breeding Classes: Either official 4-H dress code (White shirt, dark pants) or collared western shirt with black or dark jeans and polished boots.

Market Sale: Either official 4-H dress code (White shirt, dark pants) or collared western shirt with black or dark jeans and polished boots.

FFA Dress code: Official Dress for Showmanship and Sale. White shirt, black pants for Market/Breeding Classes.

SHOWMANSHIP RULES:

- NO outside groomers/fitters are permitted at Fair for any shows or the sale. Only 4-H & FFA members will be permitted to fit animals. Younger members are encouraged to get assistance from project leader or other Gallatin County 4-H/FFA members. Animals will be disqualified from the species' showmanship show if this rule is broken.
- 2. Only 4-H & FFA members are eligible to hold animals in the show ring.
- 3. 4-H or FFA members must be exhibiting their project animal enrolled in that project to participate in the showmanship contest.

SHOWMANSHIP FOR BREEDING ANIMALS: (applies to all species except dogs and cats)

- 1. Animals shown in breeding classes may not be shown in market classes or vice versa.
- 2. Animals entered in breeding classes will be judged on breed type and characteristics. Dairy Cattle and Dairy Goats will receive consideration for milk producing characteristics and development for age.

SHOWMANSHIP CONTEST AWARDS:

Each species will present awards for their Champion and Reserve Champion Showman in the Junior and Senior divisions. The Grand and Reserve Showman Junior and Senior from each species will participate in the Round Robin.

ROUND ROBIN SHOWMANSHIP COMPETITION:

General Rules:

- 1. Large animals and small animals will be combined for the Round Robin Event.
- 2. The Junior and Senior Grand Champion and Reserve Champion Showman will be selected from each species (Market Beef, Meat Goat, Dairy Goat, Sheep, Dairy Cow, Swine, Rabbit, Poultry, Horse and Dog) to compete in the Round Robin.
 - a. *For Dog exhibitors, only the Grand Junior and Grand Senior from Obedience and Agility competitions will move onto Round Robin.
- 3. The Grand Champion and Reserve Champion Showman from the above will be the four contestants selected from each species to compete in the Round Robin. The 3rd, 4th and 5th place showman from each species will be identified to provide alternates to Round Robin if necessary.
- 4. If the same showman wins Grand or Reserve in more than one species, that Showman may choose which species to show in the Round Robin and are still eligible to win the trophy for any species won.
 - a. **NOTE:** Showmen who qualify for Round Robin will be <u>required</u> to show <u>all</u> species in the Round Robin competition. If a showman does not agree to show all species, they will be required to forfeit from Round Robin and relinquish their spot to the next qualifying showman in their species.
- 5. The contestant will show at (9) species stations but will not show or be scored on the species they qualified in for the Round Robin competition.

6. Species committees will determine the stock that is used. An animal that is not well behaved or poses an undue risk to the other exhibitors will be replaced but must be approved by the species committee. Species committee members, 4-H Agent or FFA advisors may switch animals out for the safety of the animal and/or exhibitors.

ROUND ROBIN SHOWMANSHIP GUIDELINES:

Members participating in Round Robin need to follow the same showmanship attire for the species which they qualified. All participants are required to wear boots, for the safety of the youth participant. Refer to species department rules for further guidelines or contact a species committee member.

ROUND ROBIN JUDGING CRITERIA AND SCORING:

- 1. Judging and scoring will be based on the personal presentation of the exhibitor (appearance, attitude, eye contact), control of the animal (maneuvering and handling the animal confidently), showing of the animal (set up, posing, pattern, awareness of judge), and responses to 2-3 questions from the judge while showing.
- 2. All competitors will be scored on a 1 to 5 system. (For example, 1 being very poor, 2 being poor, 3 being good, 4 being very good and 5 being excellent. A total of 20 points will be available; no decimal points will be given.
- 3. Fine or technical points should not be overemphasized to the extent that they are given more weight than an effective job of presenting a clean animal, nor should minor infractions result in disqualification of a show-person.
- 4. In the case of a tie, individuals' questions scores will be totaled and the individual with the highest total questions score will win the tie.
- 5. Each round will last approximately 5-8 minutes.

MARKET SALE RULES: **Market Sale Rules are listed in order of precedence.

- 1. Animals **must** be exhibited in a Market Class to be eligible to sell.
- 2. Exhibitors are limited to selling <u>2-animal units</u>. Please refer to species specific project rules as some projects restrict animal units for first year members.
 - 1 beef = 2 animal units 1 sheep = 1 animal unit
 - 1 swine = 1 animal unit
 - 1 goat = 1 animal unit
 - Pen of 3 rabbits = 1 animal unit
 - Pen of 3 poultry = 1 animal unit
- 3. Champions and Reserve Champions must sell *unless* they exceed the 2-animal unit limit for exhibitors in the Market Sale. The Market Sale is intended to be a terminal sale. Animals selling through the Market Sale must be declared by 6PM on Wednesday of fair week.
- 4. Declared market animals are accepted with the understanding that they will be sold at the auction after they have been exhibited and judged, unless released by the 4-H/FFA Market Livestock Committee.
- 5. Exhibitors must show their own animal in Showmanship and at the Market Sale. Exceptions such as medical and family emergencies must be approved by majority vote of the 4-H/FFA Market Livestock Committee. Exception forms are available at the 4-H Office.
- 6. All market animals will be weighed at official Fair weigh-in time. This weight is the official weight.
- 7. All market animals will be weighed once. In the event of an equipment malfunction, all animals in that species will be re-weighed. Margin of error is at the discretion of the project committees.
- 8. Satisfactory Bill-of Sale must be provided for all market beef at the time animals are weighed. Provisions for releasing mortgaged stock must also be made prior to sale.
- All animals sold are subject to slaughter inspections. If condemned, carcass will be disposed of at the discretion of the authorities and all money will be refunded to the purchaser. Refunds will be made at the discretion of the 4-H/FFA Market Sale Committee.
- 10. Exhibitor must take care of their animal(s) until the species check-out time of fair week.
- 11. Refer to Gallatin County 4-H/FFA Livestock Project Contract and species contracts for additional policies.

COMMISSIONS & WITHHOLDINGS:

- A 5% commission is deducted from the sale price of each animal to pay sale expenses and operating fees. This commission covers but is not limited to the following: Livestock Judge, Buyers BBQ, Insurance coverage, Trucking fees of animals, Auctioneers, Online Sale Platform, Marketing and Advertising prior to sale, Thank you Tab publication after the fair, Equipment and Supplies for the sale, Tax fees, and Donation to Higher Education Scholarships for 4-H youth.
- 2. The 5% commission will also be deducted from all add-ons.
- All Market Swine will be deducted a rate of \$0.40 per every \$100 of the sale price to cover the Pork Checkoff Fees. For example, if you sell a market hog for \$2,000, you would multiply that amount times 0.004 (2000 x 0.004 = \$8.00).
- 4. Sale bids are unrestricted no one's selling price constitutes a ceiling. Proxy buyers must present a current proxy form with a buyer's signature and an upper bid limit when registering for the sale. Proxy buyers who exceed the agreed upon upper bid limit will be personally responsible for the difference in dollar amount.
- 5. A written thank you should be mailed directly to the buyer immediately following the sale. A list of buyers will be available through the Market Livestock Committee.
- Exhibitor Checks: We estimate that youth exhibitors will receive their checks by October 1st of the current year. We will communicate if there are any additional delays beyond our control to the best of our abilities.
 - a. *New Check Dispersal Policy: Exhibitors will be notified via email when Market Sale and Premium Award Checks are available. <u>Checks will no longer be mailed</u> and all 4-H/FFA Exhibitors will be required to <u>pick up</u> their checks at the 4-H Office.

DEPARTMENT: BEEF

BEEF COMMITTEE: Annabel Morgan, Seth Halverson, Melanie Duffin, Kelly Pavlik, Craig DeBoer **GENERAL RULES:**

Each exhibitor, parent and leader participating in this department is responsible for reading and complying with the Livestock General Rules and information section pertaining to this specific project. Members must be currently enrolled in the Beef project through Gallatin County 4-H or FFA.

Entry fees of \$15.00/head + \$15.00 for each animal entered in carcass contest are due with completed registration to the Gallatin County Extension office by entry deadline.

ALL requirements must be met on the Beef Project Requirement Agreement that all members sign at the time of the initial January weigh-in.

All 4-H beef members are required to complete a record book and an interview prior to fair for the beef project. Interview times will be scheduled online. All exhibitors will participate in an Educational Written Test. This written test will be given at the Fair at the mandatory meeting. Tests will be given according to Novice, Junior, and Senior class, and tests will be graded.

It is required to participate in Showmanship. If an exhibitor chooses to use a female for their showmanship entry, and safety cannot be maintained due to a mixed sex class, the female may be dismissed. However, the exhibitor will still be placed by the judge. Age divisions are as follows: Novice (first year), Junior (ages 10-13), Senior (ages 14 & up). Only the Grand and Reserve from the Junior and Senior Divisions will be eligible for the Round Robin.

All beef cattle must be shown on a beef cattle show halter, with a short lead for proper safety and control. Show halters must be used for ALL beef shows. Calves less than 6 months of age may be shown on a rope halter. The beef committee reserves the right to determine whether your halter is appropriate and meets the safety requirements. Rope halters must be used on all beef animals anytime they are not actively preparing to show, or showing. Neck ropes must be used on all beef cattle in the barn and in the tie out area outside whenever the member is not actively working with the animal. Cattle must remain in the barn until the designated tie-out time of 6:00 p.m. unless otherwise stated by the Beef Committee. Animals must be tied in the barn and be fed and watered before 9:00 a.m.

RULES & REGULATIONS:

- Brucellosis requirements for the Beef project: If you animal(s) live or graze in the DSA area, you must show proof
 of current blood tests for all 4-H events. Proof will be required at fair Vet check-in. Failure to show proof will
 disqualify all of your animals that are housed together. If your other animals are housed separately, you may be
 eligible to participate with animals that show proof of a negative test, with the approval and consent of a
 supervising vet. All sexually intact cattle must be tested for Brucellosis within 30 days prior to leaving the DSA, for
 the 4-H fair, any 4-H related events or changing ownership
- 2. All market and carcass beef must be owned and in possession of 4-H member by the mandatory January weigh in, no less than 180 days prior to fair. The exhibitor must be the primary caretaker of the animal. Market beef must be born after January 1 of prior year. Exception: Grass Fed beef projects must be no older than 24 months by the date of Fair. Breeding animals must be owned and cared for by member at least 90 days prior to the Fair. Proof of ownership, contract or share agreement will be required. 90-Day rule does not apply to breeding stock that is an offspring of a female project animal owned by the exhibitor.
- 3. Eligible market entries must weigh at least 1050 lbs. to be eligible to sell through the market sale. Entries under 1050 lbs. will be shown in a feeder class. Market animals will go across the scale once during check in time. Any beef over 1450 lbs. will be sold as a beef weighing 1450 lbs. No weight slips will be accepted.
- 4. Each exhibitor may enter and exhibit up to two Market Beef and unlimited breeding beef on their registration. Market Beef will compete in divided classes. Classes will be determined at the time of the show based upon

weight and the number of entries. Weights will also be made available to the judge. Grand and Reserve Overall Champion will be selected from the top two (1st & 2nd) place winners from each of the weight classes.

- 5. Beef will not be allowed to show with tags other than an Eid or the official Gallatin Co. administered tag. If an animal loses its official Gallatin County tag, you must contact a beef leader to retag your animal. Animals must be retagged BEFORE fair check-in, NOT at check-in.
- 6. Immediately following the Market show, and no later than 6:30 pm, exhibitors must let the Beef Committee know which animal they will be selling. This decision is final, and changes may not be made. Grand and Reserve Champion Market beef must sell unless they exceed the 2-animal limit for exhibitors in the Market Sale. In this case, the third overall will sell in the place of the Reserve Champion. This is so that the one animal unit rule stands from the Market Livestock Sale Rules.
- 7. Steers or heifers are eligible to be exhibited in the Market Class. Steers must be castrated prior to January weighin. Exhibitors must prove that the market heifer is pregnancy-checked open by a veterinarian or certified technician within 30 days of Fair. Market heifers that are not spayed will be required to monitor and time heat cycles to promoted safety in a mixed sex project. Every effort will be made to prevent a female from cycling during the fair dates. This process will be approved by a supervising vet to observe withdrawal times and maintain meat quality assurance.
- 8. The natural color of a market or breeding animal cannot be altered using any artificial coloring. However, products that match the animal's natural color may be used in the fitting process from the knees and hocks down and on the switch only. For example, black products may be used on a black-legged animal, red on a red-legged animal, and white on a white-legged animal. But under no circumstances can color be used to cover an animal's natural color or pattern, anywhere on the body. Refer to the national code of ethical fitting. Disqualification for breaking this rule will results in selling last in order of Beef in the Market Sale. After initial beef check-in, all animals must be fitted by enrolled 4-H youth members only. Parents may only intervene for safety reasons. Professional fitters are not allowed under any circumstance. Animals can be disqualified if this rule is proven to have been broken.
- 9. A vet check is required upon arrival at the fairgrounds and before the animals can be unloaded and stalled in the barn. A vet will be available at the time of the weigh-in. All parents and kids will complete and sign the vet form agreeing they are disclosing all medical care or issues from the entire project term. (Example- a long lasting infection, even early in the project, could affect meat quality.) Once the animals check into fair, the member or parents are no longer allowed to treat for medical issues on their own. A vet and the beef leaders will use their discretion for all medical care. Not following this could result in termination of exhibitor.
- 10. If a sedative must be used, the sedative must be prescribed and administered by a licensed veterinarian after the approval of the Beef Committee. Homeopathic substances must also be approved by the Beef Committee and supervising vet. Use of unapproved substances can result in disqualification.
- 11. A proper bill of sale or brand inspection is required at check-in.
- 12. Market Beef and Breeding animals must be without horns. For Breeding animals only, an exception may be made for horns of a Heritage breed (Please see requirements in Beef Breeding: Heritage Breed rules). Dehorned animals with scurs less than 2 inches may be allowed with written approval by the beef committee.
- 13. All animals must remain under control for the entirety of the week. If the animal is deemed as unsafe, the Beef Committee, the Livestock Committee, Extension Office, and Gallatin County Fairgrounds have the right to remove animal from the fairgrounds and the market sale.
- 14. The Beef Committee has the right to amend any rule when needed.

DIVISION 200: BEEF MARKET

Exhibitor may enter up to two market beef, 1050 pounds and over. Class will be split according to weight and number of entries. An entry fee of \$15.00/head is due with completed registration. (If you are bringing additional animals, please enter this division for each animal)

CLASS 1 Market Beef

DIVISION 201: BEEF ULTRASOUND CARCASS EVALUATION

To be considered in the carcass evaluation contest, you must enter each animal during registration and pay \$15.00 per head. Award money will be paid to the top four places.

CLASS 1 Carcass Evaluation Contest

DIVISION 202: BEEF SHOWMANSHIP (Required of all exhibitors)

- CLASS 1 Novice Division (first year member, any age-if you opt to show here, not eligible for Round Robin)
- CLASS 2 Junior Division (ages 10-13)
- CLASS 3 Senior Division (ages 14+)

DIVISION 203: BEEF BREEDING

All registered stockowners must show original breed certificates in own name or transfer papers including ownership. Livestock must be owned and cared for by the youth member ninety (90) days prior to the Fair. Proof of ownership, contract or share agreement will be required. Ninety-Day rule does not apply to breeding stock that is an offspring of a female project animal owned by the exhibitor. Project animals are defined as animals tagged, tattooed, weighed, or declared before the species deadlines.

- CLASS 1 Junior Heifer Calves (calved Jan. 1st and after)
- CLASS 2 Senior Heifer Calves (calved Sept. 1st Dec. 31st)
- CLASS 3 Summer Yearling Heifers (calved May 1st- Aug 31st)
- CLASS 4 Junior Yearling Heifers (calved Jan 1st- Apr 30th)
- CLASS 5 Cow-Calf Pair (with calf at side)
- CLASS 6 Junior Bull Calves (calved Jan. 1st and after)
- CLASS 7 Pen Show (halter broke bred heifer, cow calf pair, displayed in pen)
- CLASS 8 Heritage Breeds -

Heritage Breed Rules:

- 1. **Horns may be allowed on a classified Heritage breed if horns follow the breed standard.
- 2. All Heritage breeds with horns (individuals or cow/calf pairs) will be displayed in a pen, not tied with other beef exhibits. All horned animals must remain in their assigned pens unless they are actively preparing to show or are showing. If the exhibitor needs to take a horned animal to the wash rack, prior arrangements must be made with a beef leader.
- 3. Horned animals will not be allowed in the Beef tie outs. All horned animals will be shown with the highest level of safety in mind. Any unruly behavior or safety concerns will result in immediate dismissal from the show. Horned animals may **NOT** be used for showmanship.
- 4. Veterinarian approval of safety must be submitted with ownership documentation at least 90 days prior to fair. It is the members responsibility to adhere to any veterinarian safety requirements for horn modification, which will align with breed standards as well as veterinarian discretion.

DIVISION 204: BEEF WRITTEN TEST (Required of all exhibitors)

The Educational Written Test will be given at the mandatory beef project meeting during Fair. Tests will be given according to age and will be graded.

- CLASS 1 Novice (first year in project)
- CLASS 2 Junior (4-H ages 10-13)
- CLASS 3 Senior (4-H ages 14+)

DIVISION 205: BEEF SPECIALTY

To establish a specialty class, there must be 8 or more qualifying entries. Specialty classes can be awarded a Grand and Reserve Champion.

CLASS 1 Gallatin County Bred & Fed – Open to any market steer or market heifer "bred, born and raised to finish" in Gallatin County. Eligibility will be determined by COOL forms. Award money is collected from sponsors and divided among live show winners and carcass winners. To win award money from the bred and fed carcass portion, you must enter the carcass contest.

CLASS 2 Park Gallatin Hereford Association – Open to any steer with at least ½ Hereford breeding, the top four places will receive monies from the Park Gallatin Hereford Association - \$100 to 1st place, \$75 to 2nd place, \$60 to 3rd & \$50 to 4th place.

CLASS 3 Red Angus – Must have 5 or more qualified entries to hold this class. Animals must be more than 50% Red Angus.

BEEF SPECIALTY AWARDS

The Montana Hereford Association, Lorrie Wacker, 143 Muddy Loop Road, Plentywood, MT 59254, (406) 895-2670:

- Hereford Windbreaker Jacket to a County or multi-County Grand Champion Steer of the live show if properly documented as a Hereford
- Hereford Windbreaker Jacket to a County or multi-County Top Steer of Merit or equivalent, (i.e., in counties using ultrasound rather than actual plant measurements), if properly documented as being at least 50% Hereford ancestry
- Hereford Windbreaker Jacket to a County or multi-County Supreme Champion Female or equivalent, (i.e., overall breeds and ages showing), if documented as being purebred Hereford
- Certificate of Achievement to a County or multi-County Champion Hereford Steer or Female if documented as being Hereford. Award winners will be notified of and be invited to the annual Montana Hereford Association convention and Beef Bash held in conjunction with the Montana Stockgrowers Convention in Billings in December. Awards will be shipped to those not able to attend.

The Park/Gallatin Hereford Association will award \$25.00 to the Champion Heifer and \$15.00 to the Reserve Champion Heifer if they are at least 50% blood Hereford. They will award \$150.00 to the Grand Champion Market Steer if it is straight Hereford.

The Montana Angus Auxiliary will award a Jacket to the winning 4-H or FFA Exhibitor with an Angus Breeding Project, within the following criteria:

- Winner must have competed & won against three other breeds, not necessarily all Black Angus.
- Winner must be straight-bred BLACK ANGUS, registered or commercial, (Red Angus do not qualify).
- Exhibitor must own the animal prior to the Fair, leased show animals are not eligible.

The Montana Angus Auxiliary sponsors a Montana Silversmiths Angus Belt Buckle to the outstanding junior exhibitor with a Black Angus Heifer, Cow, Cow/Calf pair in the breeding project at the Fair. The following guidelines will apply:

- Black Angus breeding stock receiving a blue ribbon in the show are eligible (Red Angus do not qualify).
- Quality of the exhibitor's project must be considered.
- Steers will no longer be considered for this award
- Size of the project (number of animals exhibited), completed record system, & related projects could be considered, if necessary.
- Exhibitor must own the animal prior to Fair, leased show animals are not eligible.

The Montana Red Angus Association will award a buckle to a Red Angus steer or female if the animal is Overall Grand Champion or Reserve Champion of the breeding class, market class or carcass competition. To win this award, the steer or female are to be the progeny of a registered Red Angus bull or out of a registered Red Angus cow and be at least 50% Red Angus. Please contact the association at the end of your fair if the county has qualifiers. The presentation of the award is made at the MTRAA annual happenings. The Montana Simmental Association will give an award for the Grand Champion Market Steer, Grand Champion Carcass and Grand Champion Female for 4-H or FFA, if the animal is identified on their stall or barn card as being Simmental or Simmental cross. DEPARTMENT: DAIRY COW

PROJECT LEADERS: Shawna Oostema and Cassie Smieja

GENERAL RULES:

Each exhibitor and parent participating in this department is responsible for reading and complying with the Livestock General Rules and the additional information section pertaining to this project. Members must be currently enrolled in the dairy project and all animals shown at the fair must have been in the exhibitor's possession by May 1, 2025, or the parent to the animal must be on 4-H records by May 1, 2025.

Entry fees of \$15/exhibitor are due with completed registration.

All 4-H members are required to complete a record book and an interview prior to the fair and all check-in and check-out times must be followed. Each exhibitor is responsible for checking in their own animals during the vet check/check in time at fair.

Exhibitors may check-in to the Fair any time between 8am-8pm on Tuesday, July 15th. All Dairy must be in place by Wednesday, July 16th by 10am. Alterations to the check-in and check-out times may be considered but such requests must be made well in advance to the project leader and are subject to approval. Each exhibitor will also be required to participate in the showmanship division at either the junior or senior level based on the exhibitor's age. Each exhibitor is also required to create a poster on a dairy-related topic to be displayed within the barn area.

Neck ropes must be used on all dairy animals which are stalled in the barn area. All animals must be fed/watered and milked out before 9:00am and stalls must always be presentable to the public. Exhibitors and legal guardians will also be required to sign up for barn duty throughout the week. An award will be given at the end of the fair week to the exhibitor(s) who best demonstrates good herdsmanship throughout the week.

DIVISION 210: DAIRY COW SHOWMANSHIP (Required of all exhibitors)

CLASS 1 Junior Division (ages 8-13) CLASS 2 Senior Division (ages 14+)

DIVISION 211: DAIRY COW BREED SHOW

The top placing animals from each class will be judged for Grand and Reserve of Show immediately following the completion of the breed/age show. Age is based on how old the animal is as of the fair check-in date.

- CLASS 1 Bull Calf
- CLASS 2 Heifer Calf (under 7 months)
- CLASS 3 Heifer Calf (7-10 months)
- CLASS 4 Summer/Junior Heifer (11-16 months)
- CLASS 5 Winter/Senior Heifer (17-23 months)
- CLASS 6 Junior Milking (2-4 years old)
- CLASS 7 Senior Milking (4+ years old)

DIVISION 212: EDUCATIONAL POSTER (Required of all exhibitors)

A poster of a dairy related topic is required to be completed by all dairy project members. Posters must be ready to be displayed on fair check-in day.

- CLASS 1 Junior Poster (4-H ages 8-13)
- CLASS 2 Senior Poster (4-H ages 14+)

DEPARTMENT: GOATS

GOAT COMMITTEE: Lea'h MacDonald, Amy Brownell, Cassandra Mitchell, Rachel Colton

GENERAL RULES:

Each exhibitor, parent and leader participating in this department is responsible for reading and complying with the Livestock General Rules and information section pertaining to this specific project.

Members must be currently enrolled in the Goat project through Gallatin County 4-H or FFA.

All 4-H Goat members are required to complete a record book and an interview for the Goat project. Interview times will be scheduled online. AQA is required for both Market and Dairy Goat projects. Market goat project members are required to sign the Market Livestock Contract and a Market Goat contract.

Exhibitors must have attended at least **four** approved workshops including at least one showmanship workshop by fair. It is also required for members to attend tagging and weigh-ins.

An entry fee of \$10.00 per animal will be charged. There will be no charge for Doelings and Bucklings (6 months & under).

It is required to participate in Showmanship. Only the Grand and Reserve from the Junior and Senior Divisions will be eligible for the Round Robin.

Junior members in Goat (except first year members) are required to enter an educational option, these will be displayed in the Livestock barn. Senior members have the option of taking a test or entering an educational poster.

Junior and Senior members must handle, wash, clip and fit their goats with no adult help (including parents) unless there is a safety concern. In that case, a committee member must be notified. If a non-4-H member is caught helping without committee permission during the fair, the exhibitor will be disqualified from showmanship. Novice and first year Junior members may have assistance. If a member is in multiple projects and requires some assistance with feeding/caring for their goat, please let a committee member know beforehand when they will need the help from a family member/friend.

No breeding age bucks will be allowed. All Dairy Goats must be polled or disbudded (exceptions may be approved by the livestock committee).

All animals must have gone through a veterinary check no more than 3 days prior to Fair or may go through inspection during Fair check-in (refer to schedule).

All dairy goats must be CL/CAE tested once. Documentation must be turned into the goat committee by July 1st.

The Goat Committee has the right to amend any rule when needed.

DRESS CODE:

Dairy Goat - White pants and white top required for breed and showmanship.

Market Goat – Dark pants or jeans, nice show shirt or black polo market goat shirt (if offered through the project for that year).

Showmanship follows the dress code for the animal you are showing in showmanship. Boots are recommended for all classes. FFA Official Dress required for FFA members.

DIVISION 220: MARKET GOAT

Exhibitors may tag up to five market goats, but only sell up to two animal-units total through the sale. Market goats can be wethers or does. Market goats must be born on November 1st or after the current 4-H year and must be in possession by May 5th for mandatory tag and weight. A bill of sale that includes the birth date and castration date will need to be provided at this time. Castration must be done no later than 14 weeks of age. If not, the goat will be disqualified from show and sale. This includes a retained testicle. Goats must weigh a minimum of <u>70 lbs.</u>

Members are required to show in both market class and showmanship, or they will not participate in the sale. Only the market goat member may sell their market goat at the livestock auction. An entry fee of \$10.00/head is due with completed registration. If you are bringing additional animals, please enter this division for each animal.

CLASS 1 Market Goat

DHI milk testing is a vital tool for any dairy program. You can learn a lot about your dairy goat's diet, breeding, genetics and much more. All members are encouraged to participate in milk testing so you can have a snapshot of how their animals are producing. Milk will be tested through the Washington DHIA.

ELIGIBILITY REQUIREMENTS:

- 1. Does must be at least two weeks fresh
- 2. All breeds are welcome to compete and animals will be scored based on their breed standards. If they are a cross breed, they will be scored based on what those breeds should produce.
- 3. If animals are registered and their paperwork is in order with the registry, they may be eligible for milk stars. If you are hoping to achieve a milk star, please check your registry prior to fair and make sure you have all the required steps completed so the doe can be awarded the star.
- 4. **Milk testing fees will be \$4.00 per goat enrolled.** This will cover the costs of tests, paperwork and shipping fees.

TESTING PROTOCOL:

- 1. The doe will be milked out the night before (12 hours prior to the first test) and they must be verified as completely milked out. The time will be noted by a certified tester.
- 2. The day of the test, 12 hours after the initial milking, the goat will be milked out and the milk weighed. This will be monitored by the tester, timed, and weighed on a certified scale.
- 3. The second test must be done 12 hours after the first test. Again, this test will be monitored, timed, and weighed by the tester.
- 4. Milk samples will be taken from the milk after weighing and will be sent to Washington DHIA lab for testing.

GENERAL RULES:

Each exhibitor, parent and leader participating in this department is responsible for reading and complying with the Livestock General Rules and information section pertaining to this specific project.

Members must be currently enrolled in the Sheep Project. Exhibitors must have signed a "contract" and attended at least four (4) approved workshops by June 25th.

All Sheep members are required to complete a record book, seven (7) activities in the current years project book, and an interview for the sheep project. Interview times will be scheduled online.

Entry fees of \$15.00/animal are due with completed registration by 4-H Fair registration deadline.

All exhibitors, except first year Novice, must enter and exhibit an Educational Poster (displayed in the Sheep barn – due at 6 pm Monday at check in).

Trophies may be awarded at Judge or Committee discretion providing exhibits exceed one entry per class and meet blue ribbon or higher standards.

Exhibitors must be checked out by a committee member prior to release. Members leaving equipment, stalls, or barn area dirty will be charged a cleaning fee of \$25 to be deducted from your market sale check after the sale of your animals.

RULES & REGULATIONS:

All sheep entering the fairgrounds must undergo a veterinary check or must have a current health certificate. Before being admitted to the fair, sheep must be sound, in good health, and free of communicable diseases.

Market lambs must be owned by the exhibitor, ear tagged by the Sheep Committee, have a breeder's Scrapie ear tag and be in the member's possession/care for a minimum of 70 days prior to Fair. Each Exhibitor can enter a maximum of 2 market lambs in the Gallatin County 4-H/FFA Fair.

All market lambs shall be slick shorn prior to fair weigh in.

Lambs must weigh at least 110 lbs. at check in. Lambs under 110 lbs. will not be allowed to sell but will be allowed to show in the feeder class. Lambs weighing over 160 pounds will be sold at 160 pounds. Lambs will be divided into weight classes. Enter each lamb separately.

If a 4-H member has 2 lambs in one weight class, they may find another Gallatin County 4-H/ FFA member to show for them. If a member cannot show their own lambs in the market class, other arrangements must be made with another Gallatin County 4-H/FFA member to show for them. The Sheep Committee must be notified in advance and will review and make all decisions on the request.

All breeding project animals <u>must</u> be present at tagging (May 4th, 2025) to confirm ownership. All breeding stock of any age must be identified with a Federal Scrapie Program identification number. This requirement also applies to all ewe lambs entered in market lamb classes. If the designated lamb does not have a Scrapie Tag, it will not be allowed to enter the fair.

Halters, including chain, phantom, or rope, will not be allowed in the show ring. However, in the Novice class, exceptions may be granted with prior committee approval.

DIVISION 240: SHEEP MARKET

Entries can be either ewes or wethers. To sell their lambs in the market sale, exhibitors must participate in showmanship and lamb(s) must be shown in the market show. All market lambs shall be slick shorn prior to fair weigh in. If you are bringing additional animals, please enter this division for each animal.

ALL requirements must be met on the Swine Project Contract and the Gallatin County 4-H Livestock Contract that all members sign, including but not limited to Dress Code and Code of Conduct.

An entry fee of \$20.00/animal is due with completed registration by 4-H registration deadline.

Members must be currently enrolled in the Swine project through Gallatin County 4-H or FFA.

All 4-H Swine members are required to complete a Record Book, seven new workbook activities per year and a project interview for the Swine project. Level 3 members can seek substitution to workbook activities with approval of the committee.

All 4-H and FFA Swine Members are required to participate in Showmanship. First year Swine Project members may show in the Novice Showmanship class regardless of age. Only the Grand and Reserve from the Junior and Senior Divisions will be eligible for the Round Robin.

All 4-H and FFA Swine Members are required to enter an Educational Poster. They will be displayed in the Livestock Barn. The posters must be on display no later than Wednesday at 8 a.m. Members may not participate in the Market Sale if they do not enter and appropriately display a poster.

Ultrasound Carcass Evaluations will be done for all entered animals (must be enrolled in Division 250 Market Swine). All animals evaluated will be eligible for the Carcass Contest Awards. The current Montana Symbol of Excellence Carcass Standards will be utilized. Award money will be paid to the top ten (10) places and results will be emailed when they become available after the fair.

All 4-H and FFA Swine Members that sell in the Market Livestock Sale are subject to the 5% commission as well as a deduction of \$0.40 per \$100 of their sales to cover Pork Checkoff Fees. Please reference RULES FOR 4-H & FFA ANIMAL PROJECTS/ MARKET SALE RULES (see pg. 31) for more information on these fees.

RULES AND REGULATIONS:

Exhibitors are allowed to exhibit two (2) Market Weight Animals; two may be shown in market class. First year Swine Project Members that have not been in a Market Livestock Project before will only be allowed to exhibit one (1) Market Weight Animal, one will be shown in the Market Class.

All swine entering the fairgrounds must be tagged with a Gallatin County issued tag and must undergo a veterinary check before the animals can be unloaded and stalled in the barn. A vet will be provided by the Swine Project at the time of the check in.

Market Swine will compete in divided classes. Classes will be determined at the time of the show based upon weight and the number of entries.

GENERAL RULES:

Birds must be in possession by May 1, 2025, or on confirmed delivery (market birds) by March 20, 2025.

Exhibitors must complete a poultry interview. The interview will be held during the main project interview time held prior to fair. Exhibitors are asked to dust their birds for lice 7 days prior to check-in at the Fair.

A veterinarian or licensed tech will check all birds at check-in. Exhibitors may be asked to take a bird home, due to infestation with lice, illness, stress, or poor condition. Disregard of animal health and the health of other 4-Her's animals is grounds for expulsion from the Fair.

All birds must be banded. Leg band numbers must be listed for each individual bird on the coop card displayed at fair.

Entry fee is \$15.00/member (up to 10 entries and a trio/pair is considered 1 entry). If any one individual is planning on taking more than 10 entries, please contact a project leader prior to submitting your entry to the 4-H office. The entry fee is used for judging costs and awards given out to members.

An additional deposit of \$20.00/member will be due at the time of check-in. This deposit will be held during fair and returned to the member during checkout on Sunday if all barn rules have been followed throughout the fair week. Additionally, the poultry committee reserves the right to not give the members earned prizes if barn rules are not followed.

Please contact a project leader or refer to your signed contract for further details or questions.

BARN RULES:

Animals are to be fed and watered at least twice daily, and cages are to be cleaned daily. Arrangements can be made with fellow 4-H'ers to share this responsibility. In addition to caring for their birds, exhibitors are responsible for keeping the rest of the barn clean. This includes sweeping, picking up after yourself and making sure no trash is laying about. Courtesy and good sportsmanship is the order of the day.

Exhibitors (not the parents) are responsible for ensuring that they and their poultry are properly checked-in and checkedout, banded, interviewed, shown, weighed, photographed & sold at the appropriate times.

Animals are to remain throughout the Fair, to be released as noted during fair, unless the Poultry Committee rules otherwise. The exhibitor is responsible for cleaning out cages and surrounding area before they check out on Sunday.

Additionally, each exhibitor must sign up (as designated by the Poultry Committee) for barn duty during the fair. Please refer to the 2024-2025 Poultry Project Contract for further details on project requirements and expectations.

GOVERNING RULES:

The governing rules for judging will follow the most current edition of the American Poultry Association (APA) Book of Standard and posted amendments from the association and the American Bantam Association (ABA) Book of Standard and posted amendments. The market and backyard classes will be judged on the stated standards, 4-H criteria and condition of the entries. Please designate breed/variety of animal on entry for all poultry entries.

The age of the animal is based on the date of check-in on July 14, 2025

RABBIT COMMITTEE: Monica Samson and Cody Brownell

GENERAL RULES:

Exhibitor must be enrolled in the 4-H project and attend at least 4 approved workshops by July 1.

Rabbit must be owned and in the exhibitors care prior to May 1st, excluding Market rabbits. (Extreme exceptions may be considered by the rabbit committee).

An entry fee of \$5 per market class exhibitor and \$2 per animal in the breed show.

A \$15 cage cleaning deposit per cage will be due at time of check-in. The deposit will be returned at check-out after cage has been cleaned. If paid by check, the check will be held by the rabbit committee and returned at check-out.

All rabbits must pass the inspection of the veterinarian at check-in. If a rabbit is found to have any health issues that the veterinarian or rabbit committee finds a risk to the health of the rabbit or other rabbits, it will not be allowed to stay at the fair. The rabbit committee will attempt to plan for the exhibitor to participate in as many events at the fair as possible.

All 4-H rabbit members are required to complete a record book and an interview prior to the fair.

All exhibitors will participate in an educational written or online test. The test will be given at fair. Tests are given according to novice, junior and senior class and the test will be evaluated.

BARN RULES:

- 1. Rabbits must be in the Rabbit Barn during the open hours, from check-in on Monday thru check-out on Sunday.
- 2. The health and safety of the rabbits must always be a priority. The rabbit committee will intervene if necessary.
- 3. Members will feed rabbits daily and rabbits will have clean water at all times.
- 4. The cage and area under cage will be kept clean. As the rabbit is the exhibitor's project, the exhibitor should care for the rabbit and clean the cage. Other rabbit exhibitors may help each other with the care of the rabbits.
- 5. Exhibitors are responsible for having themselves and animals prepared and on time for each show.
- 6. Courtesy and good sportsmanship are expected from exhibitors.
- 7. Not following any rule including Rabbit Project Contract Rules could result in the exhibitor returning any awards and removal from the Fair.

The three rabbits chosen will need to be tattooed in their right ear by a rabbit committee member at this time. Rabbits will be judged on meat type, condition, uniformity, and fur in this order as per A.R.B.A. Standards. Exhibitors may enter 2 market pens per class and may sell up to 2 market pens depending on other animals in sale. Only market pen classes are eligible to sell.



GENERAL RULES:

- 1. Exhibitors must be enrolled in the 4-H project and has attended 3 cat meetings by July, including activities or workshops by July.
- 2. All 4-H cat project members are required to complete a record book and an interview prior to the fair.
- 3. Cats must be owned and in the exhibitor's care prior to May 1 (exceptions may be considered by the Cat project leader). Cats should be brought to the fair in a sturdy, safe and clean carrier.
- 4. PROOF OF VACCINATIONS All cats should be up to date on their core feline vaccinations, including RABIES and FVRCP.
- 5. All cats must be cleaned and well groomed, have nails fully trimmed for safety, and pass the health inspection of the veterinarian at check-in. If a cat is found to have any health issues that are a risk to the health of the cat or the other cats, it will not be allowed to participate in the show.
- 6. Exhibitors are responsible for having themselves and their cat prepared and on time for the Cat Show. An approved harness is required to be on the cat with an attached leash and with cat being attended to at all times when it is out of the carrier and during the show. Courtesy and good sportsmanship are expected from the exhibitors.

HORSE & PONY RULES:

All exhibitors are responsible for reading and understanding the rules and requirements for the show. * This includes the 4-H & FFA General Rules, Rules for Large Animals, Horse & Pony Rules, State 4-H Horse Show Rules and Gallatin County Policy Manual, Fairground Rules, and all applicable contracts with the Horse Committee. If you need ANY clarification, contact the horse committee prior to fair! Procedures and class criteria will follow the appropriate 4-H Horse project manual and the United States Equestrian Federation (USEF) Rule Book.

All project horses must be owned by the member, or in partnership with his or her immediate family. Any horse that is leased or borrowed must have a current lease contract on record with the Horse Committee. The owner must be aware of and agree to the rules outlined in the contract. Exhibitors must be enrolled in a Western and/or English Horsemanship Level and any other horse related projects in which they plan to show through Gallatin County 4-H. Participants enrolled in Horse Independent Study have unique needs and should enroll in the classes most appropriate for their situation under the direction of the project leader or horse committee. Independent study will compete for Danish only.

Horse owners may have their horses inspected by a veterinarian within the 72 hours before entering the Fair and must bring a health form completed and signed by the veterinarian. Have your Horse's Vaccination Certificate present with you. All horses must have proof of 5 Way vaccination and a West Nile Vaccination is recommended. Strangles vaccination is required for horses under the age of 5. Coggins test is recommended if you have hauled your horse from out of state. Rabies vaccination is required.

An entry fee of \$25 + \$15 each additional horse is due by 4-H registration deadline. To register horses and add fees, enter in Division 313 in ShoWorks.

Interview and record books are required of all members showing at Fair in a class. All members must attend a minimum of 3 Gallatin County horse workshops to be eligible to compete in general classes. Proof of Flu/Rhino vaccine administered between February 1 and June 1 is required. All fundraising, sponsorships and/or buyouts must be turned in by June 1.

Classes listed in this book are NOT in class order. There will be a show schedule printed prior to the show. Be sure to obtain one and refer to it for the times and locations of your classes. Classes having less than 3 entries may be canceled or combined.

HIGH POINT AWARDS:

Western Horsemanship High Point

Grand Champion and Reserve Grand Champion Highpoints will be awarded to the horse and rider combination with the most points in Level 1, Junior, Intermediate and Senior. (Classes include Western Horsemanship, Western Equitation, Showmanship, Bareback, Trail and Reining classes).

English Horsemanship High Point

Grand Champion and Reserve Grand Champion Highpoints will be awarded to the horse and rider combination with the most points in Level 1, Junior, Intermediate and Senior. (Classes include English Horsemanship, English Equitation, Dressage class A and Dressage class B classes).

Colt to Maturity/Green Horse High Point

Grand Champion and Reserve Grand Champion Highpoints will be awarded to the horse and rider combination with the most points in C2M1 (Classes include Showmanship, Obstacle Challenge, Trail in Hand), C2M2/GH1, C2M3/GH2, C2M4/GH3, G2M5/GH4 (Classes include Showmanship, Obstacle Challenge, Trail, Western and English Horsemanship, Western and English Equitation on the rail).

Points for Danishes in these classes will be used to calculate the fair portion of the Colt to Maturity and Green Horse yearend award.

Dressage High Point

Grand Champion and Reserve Grand Champion Highpoints will be awarded to the horse and rider combination with the highest score in Dressage levels 1-4. (Classes include Dressage A & B)

Jumping High Point

Grand Champion and Reserve Grand Champion Highpoints will be awarded to the horse and rider combination with the most points in Jumping Levels 1-4. (Classes include Hunter Hack, and Jumping Classes A & B).

Working Ranch Horse High Point

Grand Champion and Reserve Grand Champion Highpoints will be awarded to the horse and rider combination with the most points in WRH Levels 1-4. (Classes include Knowledge, Trail, Roping, Sorting, Ranch Riding/Working Cow Horse Pattern).

DRESS CODE:

Approved riding helmets are MANDATORY in all Western and English mounted classes. **Western** - Long sleeve blouse or shirt, western type pants, clean riding helmets in good condition; cowboy hat for groundwork, cowboy boots that are clean and polished, belt must be worn if pants have belt loops; OPTIONAL: gloves, ties, vests, jackets, chaps, and spurs. Hair that is shoulder length or longer must be contained in a net or braid.

Bareback Equitation-Western - Same as western except chaps, spurs and crops are prohibited.

Bareback Equitation - English - Long sleeve shirt must be worn without jacket, clean riding helmets in good condition required; chaps, spurs, and crops are prohibited.

English - Hunt Coat (red, scarlet, or pink coats prohibited unless exhibitor has earned them as a member of a recognized hunt), breeches, hunt boots or riding boots and ½ chaps, short or long-sleeved English Style blouse or shirt in white or pale pastel colors, clean riding helmets in good condition required; stocks, chokers or ties required; OPTIONAL: gloves, unroweled spurs and whip (crop or bat). Hair that is shoulder length or longer must be contained in a net or braid. Horse Committee may waive coats if over 85 degrees F.

Appearance of Horse – Clean coat that emphasizes luster, countdown for obvious added oils. Hair trimming should accentuate. Quality about head and legs and the characteristics of the specific breed. Hooves cleaned, properly trimmed and shaped. No Preferences will be made for hoof dressing or coloring. Tack should be clean, neat, adjusted and should complement the horse. At no time does fancy attire or equipment take precedence over suitable, workman-like attire and equipment. Western classes will be ridden in Western tack and English classes will be ridden in English tack.

GRIEVANCE PROCEDURE:

The Horse Committee will have a designated Show Manager who will hear all grievances and will take the information to the Horse Committee. If no resolution can be reached it will go to the County Extension Agent and the County Grievance Committee whose decision will be final.

Open to enrolled Horse Project members. Showmanship at halter is a class in which the handler is judged on his/her ability to show a halter horse. It requires polish and thorough preparation.

Entries in Colt to Maturity and Green Horse classes will only compete for Danish ribbons and will not be included in high point.

- (e) A minimum of one (1) lead change at the lope from left to right.

Exhibitors are allowed to use two (2) hands (as well as one or no hands) and any bit approved by the NRHA Handbook, including snaffle bits and bosals approved for use in the Snaffle Bit or Hackamore classes. Failure to perform all the required maneuvers or failure to complete the performance within the time limit will result in a score of zero (0).

Additional maneuvers such as rollbacks, backups, speed variations, and non-classical reining maneuvers such as half pass and side pass are appropriate in Freestyle and shall be given appropriate credit. Additional repetitions of required maneuvers are appropriate but will only add or subtract from the existing scores already given for the required maneuvers, not as additional scores.

Time Limit. A maximum of four (4) minutes. The time limit will begin when the music starts.
