Bowhunter: Compound bow with fixed sights (moveable only with a tool), release aid, may have stabilizer up to 12".

Limited: Compound bow with sights and finger release.

Barebow: Compound bow without sights, finger release.

Primitive: Recurve bow, no sights, finger release.

Olympic Recurve: Recurve bow, sight, stabilizer, finger release, and 11 meters for age 14 and older.

Each member needs to supply their own armguard. MSU policy requires armguards on all shooters.

Age classes are as follows:

9-10; 11-12; 13-14; 15 and up.

You will shoot the age you are as of October 1, 2025 for the entire season.
