## Montana University System Benefit Plan Employee Members <u>IMPORTANT</u>: 2025 Annual Enrollment Benefit Plan and Premium Changes

The Montana University System *Choices* Benefit Plan (MUS Plan) is your self-insured employer sponsored plan covering over 16,000 MUS employees, retirees, COBRA enrollees and family members. The MUS Plan, funded by a combination of contributions as determined by the Montana Legislature and Plan member premiums, is responsible for providing health care coverage for you and your family members in accordance with state and federal laws.

During 2024, the MUS Plan saw a significant increase in health care costs and utilization. These increases are driving necessary benefit changes and premium increases. Beginning July 1, 2025, the MUS Plan will implement medical and basic life/AD&D benefit adjustments and premium increases. For FY2026, an additional \$26/month will be added to the State employer contribution (currently \$1,054/month, increasing to \$1,080/month). Additionally, there will be increases to the diagnostic and preventive dental fee schedule amounts.

## <u>What do you need to do</u>?

- (1) If you want to make benefit changes to your MUS Plan coverages for the 2025-2026 Plan Year, please make your changes in the MUS online enrollment system, Benefitsolver, by 5:00 p.m. (MST) on **Thursday, May 15, 2025**.
- (2) If you do not want to make any changes to your current MUS Plan coverages, you will **automatically** be re-enrolled in your current benefits, except for a Flexible Spending Account, which **must** be re-elected each Plan year, and the basic life/AD&D coverage options.
